



VOLLEYBALL LEAGUE WAIVER OF LIABILITY
(Adults)

I, the undersigned, understand that I am registered to participate in a volleyball league (“Volleyball”) at Ope! Brewing Company LLC (“Ope!”) at 6751 W. National Avenue, West Allis, Wisconsin, owned by West Allis Brewing Property LLC (“WABP”).

INHERENT RISKS

I understand that Volleyball contains extremely strenuous physical activity and significant inherent risks such as falls, falling into others, close physical contact with others, being hit, pushed, or otherwise jostled, physical contact with objects such as nets, sand, and a moderately heavy ball in motion, all of which may be hazardous to my health. Participation in Volleyball may result in physical or emotional injury, including but not limited to, head, back, limb, neck, skin, muscle, tissue, bone, tendon, ligament, nerve, blood vessel and other organ injuries, including but not limited to, bruises, sprains, strains, abrasions, fractures, infections, dislocations, temporary or permanent disability or paralysis, or even death. Depending on the severity, such injuries can result in mild to severe discomfort and pain, which may be temporary or permanent and certain injuries can also result in minor to extensive, including invasive, medical intervention and treatment, including but not limited to doctor visits, hospital stays, physical therapy, and surgery.

EXISTING PHYSICAL CONDITION

By executing this Waiver of Liability, I represent and warrant that I have no personal knowledge of, nor have I been warned of, diagnosed with or treated for, any current physical, mental or emotional condition that would render participation in Volleyball dangerous and/or hazardous to my health. I promise to notify Ope immediately, in writing and delivered in person to an instructor or referee of Ope before the next scheduled session, if I suspect or become aware of, any such condition. After reasonable review of the written notification, Ope reserves the right to terminate my participation in Volleyball.

WAIVER OF LIABILITY

With full personal knowledge, I voluntarily release, waive, discharge and covenant not to sue Ope and WABP, their principals, officers, directors, representatives, agents, administrators, employees, successors, parent, sister or related entities, sponsors, advertisers, volunteers, assigns, and owners and lessors of premises on which the Volleyball take place (collectively “Released Parties”) from and against any right, claim, demand, or cause of action of any kind (excluding claims for reckless or intentional conduct), including but not limited to any bodily loss, damage, or injury, including death as further enumerated in the section titled, “Inherent Risks” above, that may be sustained by me, or to any property belonging to me, arising as a result of the Volleyball or any other activities in which I may participate at Ope or WABP, or at any event hosted by or participated in by virtue of involvement in Ope, or while training at home using Volleyball skills and methods, which any liability could be attributed to the Released Parties.

It is expressly intended that this Waiver of Liability shall bind to the members of my family and my spouse if I am alive, and to my estate, heirs, assigns, successors and personal representative(s), if I am deceased.

I represent and warrant that I am over the age of 18, have been given reasonable time and ability to review this Waiver of Liability, including consultation with legal counsel of my choice, and that after review, I fully understand the contents of this Waiver of Liability, and voluntarily elect to execute this Waiver of Liability of my own free will, with no inducements, undue influence, or duress, thereby accepting all risks inherent in participating in Volleyball and waiving actions against Ope and WABP, as further identified above.
